To All Clubs and Schools

Re: 2023 BCA's Competitions

The following adjustment is to be made to the BCA Limited Over Competition Playing Conditions as noted below: -

### 1 BCA Limited Over Competition Playing Conditions

#### 1.1 At page 4.9

##### Clause V. General

The following words are added to the above referenced clause to regulate not prevent player movement between competitions for same series and on weekends

**“, or on the same weekend.”**

The clause shall read: -

##### Clause V. (b)

“A player shall not be declared to represent more than one (1) team in the **BCA Limited Overs Competitions (SuperCup and Shield)**, on the same day, **or on the same weekend**. A player declared to play in one (1) Competition or team shall be deemed ineligible to play or substitute in another **BCA Limited Overs** Competition for his club on the same day, **or on the same weekend**. Exception to this shall be the players of the Barbados Youth and Ladies (IWP) players under the strict provisions of clause 8 of the BCA Special Conditions and Regulations of Play.”

#### 1.2 at page 4.19 and page 4.23

Clause 11.2.2 & Clause 13.7.1.7 the interval shall be 30 minutes and not 40 minutes

Clause 11.2.2 shall read: -

“Umpires/BCA Match Referee may adjust the length of the interval between innings, provided that the scheduled length of the interval in an uninterrupted match is a minimum of 15 minutes and a maximum of **30** minutes.”

Clause 13.7.1.7 shall read: -

“If the team fielding first fails to bowl the required number of overs by the scheduled time for cessation of the first innings, play shall continue until the allocated number of overs have been bowled. The Umpires shall record the number of overs started at the scheduled break time is reached. The interval shall be 30 minutes.”

2 - Addendum 2023 #01

2 BCA Special Conditions and Match Schedule Document

For the purposes of clarity, the Match Schedule document in reference to the latest start time for an innings in Shield matches states that the minimum overs used is “16 overs a side”. The minimum to be used for this purpose is 15 overs and not 16 (see clause 18.B.2 (b)). The latest start time is calculated using 4 minutes per over, that is, the latest start time is calculated without the water break to ensure that in the event of Ground, Weather or Light (GWL) interruptions during the day, a maximum effort is made to play a match. This is the only instance that a 4 minute per over can be used. In all other calculations 4.25 minutes per over must be used.
